TOWN OF DEERFIELD MONTHLY MEETING

NOVEMBER 11, 2019

On a motion by Randy Behlke, seconded by Dan Kelly the agenda was adopted. Motion carried.

A motion was approved for the October minutes with the following corrections. In paragraph 6 Jim Maple should replace the name of Bill Roelofs. In paragraph 14 the word abstaining should be inserted after Nick Brattlie to clarify Mr. Brattlie's position. Motion carried.

The town board decided to hold a joint meeting with the planning commission on Tuesday, December 3, 2019 at 6:00 P.M. in the Deerfield Community Center for the purpose of discussing updates to the town's Comprehensive Land Use Plan revision.

The town board discussed the Parking Ordinance which was adopted in October. It was decided that there were some issues with the ordinance that should be addressed. The Ordinance and possible amendments to it would be brought up at the December meeting.

The town board addressed the speed limit ordinance which was adopted in October. The ordinance would be published as a new ordinance.

There were three candidates for the snow plow operator(s) position. The decision to hire one or two would be made at the town meeting on November 25, 2019.

The town board would continue to explore the possible adoption of a sexual offender ordinance closely related to the recently adopted ordinance by the Town of Christiana.

The town board conducted a job performance review of the clerk Bob Riege who had been appointed seven months earlier. Concerns were expressed about computer knowledge lacking, more uniform meeting posting, and providing a more formal agenda to any and all meetings held by the township. After some discussion a motion was made by Randy Behlke, seconded by Dan Kelly to appoint the clerk to another six month period till May, 2020. Motion carried.

Discussion/Action for Manning Petition #2019-11476. On a motion by Bill Roelofs, seconded by Randy Behlke approval would be granted for this petition with the added recommendation by Dane County Zoning for their proposed deed restriction. Motion carried.

Several residents of Prairie Village were present to discuss with the board a possible remedy(s) for the situation of neighbors not getting along with events at the Prairie Village Park specifically one neighbor. The park is deeded in the Town of Deerfield's name, is a park dedicated to the public and as such is open to all residents. The neighborhood association which had been disbanded in the past could be recommissioned. Both the neighbors in attendance and the town board would be looking into possible actions that could be taken so that all residents could utilize the park without the disagreements which had recently surfaced.

On a motion by Bill Roelofs, seconded by Randy Behlke, the treasurer's report was approved. Motion carried.

On a motion by Nick Brattlie, seconded by Bill Roelofs, the General Fund Voucher of \$82,362.80 was approved. Motion carried.
