MONTHLY MEETING, MONDAY, MARCH 8, 2021, 7:00 P.M., DEERFIELD COMMUNITY CENTER

ALL OFFICERS WERE PRESENT IN PERSON.

ON A MOTION BY RANDY BEHLKE, SECONDED BY BILL ROELOFS, THE MEETING AGENDA WAS ADOPTED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY BILL ROELOFS, THE FEBRUARY MEETING MINUTES WERE ADOPTED.

ON A QUESTION FROM DOREEN TRUEDEN, BILL ROELOFS AGREED TO INQUIRE FROM THE TOWN'S LEGAL COUNSEL OR THE WI. TOWNS ASSOCIATION THE LEGALITIES FOR UTILIZING THE ZOOM SET UP FOR PERSONS WANTING TO ATTEND THE MEETINGS VIRTUALLY.

ON A MOTION BY BILL ROELOFS, SECONDED BY DAN KELLY, THE BOARD AGREED TO GRANT FOREVER SAND & GRAVEL THE NECESSARY MINING LICENSE FOR THE UPCOMING YEAR. ROLL CALL VOTE: ROELOFS, BEHLKE, KELLY, BRATTLIE--- AYE. SCHLOBOHM--- ABSTAINED. THERE WOULD ALSO BE A FUTURE DISCUSSION AS TO THE POSSIBLE REIMBURSEMENT OF EXCESS APPLICATION FEES FOR THE LEGAL REVIEW OF THE APPLICATION. THE TOWN HAD INCURRED \$840.00 IN LEGAL EXPENSES.

UPDATES WERE DISCUSSED ON THE LIBERTY ROAD PROJECT FOR 2022 BETWEEN THE TOWN AND VILLAGE.

UPDATES FOR THE OAK PARK ROAD PROJECT FOR 2021 WERE DISCUSSED. THE TOWN WAS ANTICIPATING ACCEPTING BIDS IN TIME TO MAKE A DECISION AT THE APRIL MEETING.

DISCUSSION WAS HELD IN REGARD TO THE KOSHKONONG SOLAR PROJECT BETWEEN THE BOARD AND CONCERNED CITIZENS.

MR. ERIC LANG AND SUPERVISOR RANDY BEHLKE GAVE A SHORT PRESENTATION OF FACTS AND FIGURES REGARDING THE DEER-GROVE EMS SERVICES.

ON A MOTION BY NICK BRATTLIE, SECONDED BY RANDY BEHLKE, THE BOARD APPROVED THE TREASURER'S REPORT AND A GENERAL FUND VOUCHER OF \$57,090.92. MOTION CARRIED.

THE BOARD AGREED TO SEND A RESOLUTION TO DANE COUNTY THANKING SHERIFF DAVID MAHONEY FOR HIS MANY YEARS OF LAW ENFORCEMENT SERVICE TO DANE COUNTY.

THE BOARD AGREED TO HAVE THE CLERK SEND A LETTER TO GFL ENVIRONMENTAL SERVICES STATING THAT THE TOWN WOULD BE SOLICITING BIDS FROM OTHER DISPOSAL AGENCIES WHEN THE CURRENT CONTRACT ENDS DECEMBER 31, 2021.
