MONTHLY MEETING, MONDAY, MAY 9, 2022, 7:00 P.M., DCC CENTER, 10 LIBERTY ST.

CHAIRMAN MIKE SCHLOBOHM CALLED THE MEETING TO ORDER WITH ALL OFFICERS PRESENT.

ON A MOTION BY RANDY BEHLKE, SECONDED BY MIKE SCHLOBOHM, THE BOARD AGREED WITH THE MEETING AGENDA WITH ONE CHANGE. ITEM 13 WOULD BE MOVED UP TO ITEM 7. MOTION CARRIED.

ON A MOTION BY KATE MICHEL, SECONDED BY RANDY BEHLKE, THE BOARD APPROVED THE APRIL MINUTES. MOTION CARRIED.

ON A MOTION BY MIKE SCHLOBOHM, SECONDED BY DAN KELLY, THE BOARD AGREED TO POSTPONE THE 2022 BOARD OF REVIEW TO WEDNESDAY, AUGUST 11, 2022. MOTION CARRIED.

ON A MOTION BY DAN KELLY, SECONDED BY KATE MICHEL, THE BOARD AGREED TO GRANT A ONE DAY ALCOHOL LICENSE TO JEFF MOERKE FOR AN EVENT TO BE HELD SUNDAY, MAY 22, 2022. MOTION CARRIED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY KATE MICHEL, THE BOARD AGREED THAT SOME OR ALL BOARD MEMBERS SHOULD OBSERVE THE TOPIC OF A POSSIBLE PARTIAL ROAD DISCONTINUANCE OF S. MISSOURI LANE AND WHERE A FUTURE CUL-DE-SAC OR Y TURN POINT SHOULD BE LOCATED. OTHER POINTS TO BE CONSIDERED WOULD BE THE OBTAINING OF A SURVEYOR FOR LOCATION PURPOSES AND ESTIMATED COSTS FOR THE PROJECT. MOTION CARRIED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY NICK BRATTLIE, THE BOARD APPROVED ZONING PETITION #11843 FOR BOB RIEGE CREATING A FOUR LOT CERTIFIED SURVEY IN SECTION 24 OF THE TOWNSHIP. MOTION CARRIED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY MIKE SCHLOBOHM, THE BOARD AGREED TO PUT OUT A SOLICITATION FOR BIDS ON 2022 ROAD WORK PROJECTS IN THE TOWN FOR OPENING AT THE JUNE MEETING. NOTICE WOULD BE PRINTED IN THE LOCAL PAPER. MOTION CARRIED.

THE BOARD AGREED TO ALLOW JIM MAPLE TO WORK ON THE FOLLOWING TWO TOPICS: REQUIREMENT OF A PERMIT FOR ROAD RIGHT-OF-WAY PROJECTS BY INDEPENDENT CONTRACTORS AND A CLARIFICATION TO THE MINING ORDINANCE WHERE THE ANNUAL RENEWAL ADMINISTRATIVE FEE OF \$3000.00 WOULD BE BILLED AT ACTUAL COSTS INCURRED BY THE TOWN.
