

TOWN OF DEERFIELD

SPECIAL MEETING, THURSDAY, SEPTEMBER 22, 2022, 6:00 P.M., TOWN GARAGE

MEETING WAS CALLED TO ORDER WITH MIKE SCHLOBOHM, KATE MICHEL, NICK BRATTLIE, DAN KELLY, RANDY BEHLKE AND BOB RIEGE IN ATTENDANCE.

THE PURPOSE OF THE MEETING WAS FOR THE TOWN OF DEERFIELD TO BEGIN THE PROCESS OF CONSIDERATION FOR WITHDRAWING FROM DANE COUNTY ZONING AND INDEPENDENTLY PERFORM THEIR OWN ZONING PROCESSES. A RESOLUTION WOULD HAVE TO BE ADOPTED BY THE TOWN BOARD FOR CONSIDERATION OF WITHDRAWAL AND SUBMITTED TO THE DANE COUNTY CLERK BY OCTOBER 7, 2022. AFTER SOME OTHER TIMELINES WERE MET, THE TOWN COULD POSSIBLY BEGIN THEIR OWN ZONING PROCESSES BY JANUARY 1, 2024. THE TOWN COULD ENLIST OUTSIDE ASSISTANCE IN COMPLETING THIS PROCEDURE.

ON A MOTION BY RANDY BEHLKE, SECONDED BY DAN KELLY, THE TOWN BOARD CONSIDERED THE FOLLOWING RESOLUTION: THE TOWN OF DEERFIELD WOULD MOVE TO SEND A NOTICE OF INTENT TO WITHDRAW FROM DANE COUNTY ZONING BY OCTOBER 7, 2022. BY ADOPTING THIS MOTION, HOWEVER, THE TOWN HAS NOT MADE A FINAL DECISION TO WITHDRAW. MOTION CARRIED WITH ALL SUPERVISORS IN ATTENDANCE VOTING "AYE".

NOTICE OF INTENT SENT TO DANE COUNTY CLERK SCOTT McDONELL: THIS LETTER IS TO PROVIDE NOTICE TO DANE COUNTY, PURSUANT TO SEC. 60.23(34), THAT THE TOWN OF DEERFIELD HAS ADOPTED A MOTION TO WITHDRAW FROM COUNTY ZONING. THE ACTUAL WITHDRAWAL DECISION, PER THE STATUTE, WILL NOT OCCUR UNTIL FURTHER ACTION IS TAKEN BY THE TOWN.

ON A MOTION BY KATE MICHEL, SECONDED BY MIKE SCHLOBOHM, THE MEETING WAS ADJOURNED AT 6:45 P.M. MOTION CARRIED.
