MONTHLY MEETING, MARCH 13, 2023, 7:00 P.M., DCC CENTER, 10 LIBERTY STREET

MIKE SCHLOBOHM CALLED THE MEETING TO ORDER AT 7:00 P.M. WITH ALL OFFICERS IN ATTENDANCE.

ON A MOTION BY RANDY BEHLKE, SECONDED BY DAN KELLY, APPROVAL WAS MADE FOR THE MARCH AGENDA. MOTION CARRIED.

ON A MOTION BY NICK BRATTLIE, SECONDED BY KATIE MICHEL, APPROVAL WAS MADE FOR THE FEBRUARY MEETING MINUTES. MOTION CARRIED.

THE PUBLIC COMMENTS AND QUESTIONS PERIOD CONTAINED COMMENTS ON THE PROGRESS OF THE KOSHKONONG CREEK STUDY, TOWN GARAGE RENOVATIONS, AND THE UPCOMING DEERFIELD SCHOOL DISTRICT REFERENDUM.

ON A MOTION BY RANDY BEHLKE, SECONDED BY DAN KELLY, THE NON METALLIC LICENSE APPLICATION, 2023, WAS APPROVED FOR FOREVEVER SAND & GRAVEL AT THE OAK PARK QUARRY FOR A TOTAL COST OF \$500.00. ROLL CALL VOTE: BEHLKE, KELLY, BRATTLIE, MICHEL VOTED "YES". SCHLOBOHM ABSTAINED.

ON A MOTION BY KATIE MICHEL, SECONDED BY RANDY BEHLKE, APPROVAL WAS GIVEN FOR A RESOLUTION TO VACATE A PORTION OF TOWN ROAD WHICH IS A PRIVATE DRIVEWAY LOCATED AT 233 FAIR OAK ROAD. MOTION CARRIED.

DISCUSSION WAS HELD ON THE NEW CONTRACT, 2024-2026, BETWEEN DEER-GROVE EMS AND THE TOWN OF DEERFIELD. NO FORMAL ACTION WAS TAKEN.

DISCUSSION WAS HELD ON THE DISBURSEMENT OF ARPA FUNDS. PLANS WERE TO GIVE SOME FUNDING TO THE DEERFIELD FIRE DEPT. FOR RADIOS.

DISCUSSION AND ACTION WAS TAKEN TO HOLD A MEETING AT THE TOWN GARAGE FOR BEGINNING DISCUSSIONS ON WHAT TYPES OF RENOVATIONS WOULD BE TRULY NEEDED TO UPDATE THE FACILITY.

ON A MOTION BY NICK BRATTLIE, SECONDED BY MIKE SCHLOBOHM, THE TREASURER'S REPORT AND THE GENERAL FUND VOUCHER OF \$39,515.87 WAS APPROVED. MOTION CARRIED.
