ON A MOTION BY RANDY BEHLKE, SECONDED BY DAN KELLY, THE AUGUST MEETING AGENDA WAS APPROVED. MOTION CARRRIED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY KATIE MICHEL, THE JULY MEETING MINUTES WERE APPROVED. MOTION CARRIED.

THE BOARD DISCUSSED AN ISSUE OR DIFFERENCE OF OPINION BETWEEN DANE COUNTY ZONING AND THE TOWN'S BUILDING INSPECTOR, STEVE REWEY, REGARDING A HOMEOWNER WANTING TO DO AN ADDITION AND REMODEL FOR A HOME ON OLSTAD ROAD. THE BOILER FOR IN FLOOR HEATING WOULD HAVE TO BE OPERATIONAL TO OBTAIN AN OCCUPANCY PERMIT.

STEVE SORDAHL, 1520 U.S. HWY. 12&18, COMPLAINED THAT HIS RECYCLING HAD NOT BEEN COLLECTED FOR THE PAST THREE MONTHS. TREASURER KORBY HOLZHUETER WOULD FOLLOW UP FOR THE BOARD TO MAKE SURE THE MATTER WAS RECTFIED.

THE BOARD DISCUSSED THE NEED BY THE TOWN AND DANE COUNTY ZONING TO REGULATE LICENSING AND POSSIBLE C.U.P. APPLICATION FOR AIR B&B RESIDENCES.
