ON A MOTION BY RANDY BEHLKE, SECONDED BY DAN KELLY, THE FEBRUARY MEETING AGENDA WAS APPROVED. MOTION CARRIED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY KATIE MICHEL, THE JANUARY MEETING MINUTES WERE APPROVED. MOTION CARRIED.

OWNERS OF SCHUSTER'S PLAYTIME FARM, DON, THERESA, SARAH, AND MITCHELL, WERE PRESENT TO REQUEST THE TOWN GRANT THE BUSINESS A COMBINATION LIQUOR LICENSE FOR THE UPCOMING YEAR, 07-01-2026 THRU 06-30-2027. THE TOWN STATED THAT A COMMITMENT WOULD BE MADE ON THE TOWN'S PART TO GRANT THEIR REQUEST.

ON A MOTION BY MIKE SCHLOBOHM, SECONDED BY RANDY BEHLKE, APPROVAL WAS GRANTED TO CLOSE MISSOURI ROAD ON 05-08-2026 FROM THE HOURS OF 8:00 A.M. THRU 1:00 P.M. MOTION CARRIED.

ON A MOTION BY RANDY BEHLKE, SECONDED BY NICK BRATTLIE, APPROVAL WAS GIVEN TO ZONING PETITION #12242 FOR TERRY CHADWICK, 1406 SCHADEL ROAD, WHICH WOULD RECONFIGURE AN EXISTING RESIDENTIAL LOT AND CREATE AN AGRICULTURAL LOT. THE TOWN WOULD ALLOW THE CURRENT FARMHOUSE TO REMAIN INTACT UNTIL THE NEW HOUSE WAS COMPLETED. MOTION CARRIED.
